Parish Council Meeting Agenda

1. Apologies for Absence:

2. Declarations of Interest for items relating to the Agenda:

4. Planning applications:

Ref: SE/21/02475/DETAIL

Development: Details pursuant to condition 6 (soft landscaping) subject to 14/02630/FUL Site: 2 Cross Cottage, Valley Road, Fawkham, KENT, DA3 8LX.

Resolved: The application was discussed and it was decided that FPC would like this request to discharge condition 6 refused, and for the specified yew trees (T5) to be planted elsewhere on the large plot, for example, to the south of the house, and for the two oak trees (T4) shown on the landscape plan to be planted to preserve and enhance the visual appearance of the area as supported by policies EN1 and EN17B of the Sevenoaks District Local Plan. Comment to be submitted to FPC.

Development: Residential caravan site and associated storage containers.

Site: Caravan Site at Woodlands Park Activity Centre, School Lane, Horton Kirby, KENT, DA3 8NZ.

Resolved: The application was discussed and it was decided that FPC object to this application, as inappropriate development in the Green Belt. Should SDC grant it, FPC would like to see permitted development rights removed to prevent further harm to the openness of the Green Belt, further harm to the Local Wildlife Site of which this is a part and further harm to the ancient woodland which immediately adjoins the site. FPC believes evidence should be provided to corroborate the statements, such as utility bills, Council Tax bills and electoral roll information, and that the declarations on their own are insufficient to provide evidence that on the balance of probability the uses have existed for more than 10 years.

If planning permission is granted, FPC would like to see conditions to imposed to mitigate the impact on the ancient woodland, as suggested by the Forestry Commission's Standing Guidance.
