#### 4. Planning applications:

Site: Trinity House Valley Road Fawkham KENT DA3 8LX

Ref: SE/21/01579/HOUSE

Development: Brick wall(s) to the north and northwestern side of the dwelling with retaining wall to the rear and fencing to the site frontage

Comment: FPC object to this planning application due to harm to the openness of the green belt and character and appearance of the area. FPC's view is that the brick walls, which are around 6' high and extend for some length (height and length are not stated in the application) are harmful to the openness of the Green Belt. The photograph submitted by the agent of the fencing proposed to be retained is not what is in situ

Site: Land South Of Cross Cottages Valley Road Fawkham KENT DA3 8LX

Ref: SE/21/01578/DETAIL

Development: Details pursuant to condition 7 (ecological enhancement plan) 18/03932/MMA.

Comment: An email had already been sent to Sevenoaks planning regarding this application. Comments will be submitted again on the formal SDC planning comments response form.

Fawkham Parish Council considers that the ecological enhancement plan seems good on paper, with most of the grass managed as meadow with two cuts a year, and the native hedges "gapped up". However, FPC is concerned that most of the trees and some of the hedgerows shown on the plan do not exist at the site, and there is no mention of these being planted as part of the plan

Site: Laredo Three Gates Road Fawkham KENT DA3 8NZ

Ref: SE/21/01762/PAE

Development: Prior notification of a single storey rear extension which extends 6 m beyond the rear wall of the original dwelling house with a maximum height of 4 m and eaves height of 2.5 m.

Comment: Fawkham Parish Council objects to this application. FPC notes that this revised application now has a reduced maximum height of 4m rather than the 4.5m height mentioned in the previous application. However as no drawings have been included in the application FPC are unable to verify the 4m height.

There will then be a further count, proposed for July, and this second set of data will then be used to validate the initial data.

Comment: Cllr L.Evans provided an update. The third Steering Group meeting has taken place. There will be a picnic on the grass area at Small Grains in August. The PC also hope to have a stall at the Church Fete in September to promote the NP. A selection has een made for the Planning Consultant.. A grant of £10,000 is currently in the process of being applied for..
