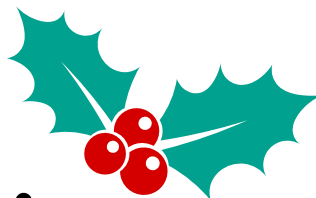

Help appealing parking fines

If you've received a Penalty Charge Notice (also known as a parking fine), you can now use our free AI powered telephone service to help you make an informed decision about whether to appeal.

When you call the service, you'll be greeted by a friendly AI assistant who'll ask a few questions about the circumstances of your Penalty Charge Notice.

If you have grounds for an appeal, the AI assistant will advise you of any evidence you may need to provide. You can also opt for the AI assistant to write the appeal for you, which would be sent to your mobile phone.

Alternatively, if there are no grounds for an appeal, the AI assistant will explain why we are unlikely to cancel your Penalty Charge Notice.

The call should last about three minutes. Usual call rates apply.

To use the service, call our dedicated helpline on **01732 902609**.

Cllr Margot McArthur, our Cabinet Member for Cleaner and Greener, says: "We're always prepared to embrace new ideas and technology that make our services available to residents at times that are convenient to them."

"Our new AI telephone service will help drivers to make an informed decision whether or not to appeal their fine. The service is available 24/7 and calls only last a few minutes. The service can even write the appeal if there are grounds for a challenge."

You can still speak with a member of staff about a Penalty Charge Notice during our usual opening hours.

Three ways to dispose of your real Christmas tree

There are lots of options available to recycle your real Christmas tree for **FREE** after this year's festivities have ended.

1 **Option 1 – Use our Garden Waste collection service (for permit holders only)**
If you hold a Garden Waste collection permit, simply place the tree in or next to your green bin and we'll pick it up on your usual collection days throughout January. We can take trees with a trunk of up to 90mm (3.5") in diameter.

2 **Option 2 – Take your tree to a local collection point**
Take your tree to one of the collection points, on the dates and times listed below, and we'll take it off your hands. We can take trees with a trunk of up to 90mm (3.5") in diameter.

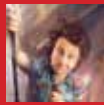

Support with energy costs for households in financial hardship



Kent County Council will be providing vouchers to eligible households to support with energy costs. This scheme is funded by the UK Government's Household Support Fund, to support vulnerable Kent households in need of help with significantly rising living costs.

You may be eligible for assistance if you:

- are aged 16 or over
- are a Kent resident (excluding Medway)
- earn below £40,000 total household income (per annum before tax)
- do not have more than £1,000 in savings
- are responsible for paying the household energy bills (one award per household)
- do not receive free school meal voucher support during the school holidays.

Pupil's poster helps improve air quality

Artwork produced by a local school pupil has been put on display outside local schools to encourage motorists to turn off their engines when parked.

Children from across the Sevenoaks District were invited to enter a poster competition to raise awareness of vehicle idling and help improve air quality around schools.

Dozens of pupils took part with the winner named as Jenson from Lady Boswell's Primary School in Sevenoaks.

Jenson's poster formed the basis of banners and posters that are now on display outside many local schools, including High Firs Primary School in Swanley.

Idling petrol and diesel vehicles can cause a number of problems. The average parked car left running for ten minutes pumps out the same amount of CO₂ as driving a three mile journey, as well as other toxic pollutants. Not only is this damaging to the environment and residents' health, it's also expensive and illegal and could land drivers with a fine.

Cllr Margot McArthur, our Cabinet Member for Cleaner and Greener says: "We were blown away by the many amazing and thoughtful posters produced by school pupils from across the District. What came out of this competition was our young people care passionately about the environment and are keen to send a message to adults that small, important changes can make a big difference to our future.

"Improving air quality is a top priority for the Council. Although we have seen year-on-year improvements in the District's air quality, we need to make sure we are all doing everything possible to ensure this trend continues."

The importance of microchipping your dog

Christmas is a time of giving and some of us may be considering a dog as a festive gift.



Making sure your new, or existing dog, is microchipped can save a lot of heartache should the unthinkable happen and they go missing.

Microchipping is quick, easy and painless and it can help make sure you're reunited with your dog quickly if they are found by our Animal Welfare Officer, and helps combat theft. It's also a legal requirement to have any dog over the age of eight weeks microchipped.

Every year we pick up over 100 dogs which have got away from their owners. Unfortunately, many of these are not microchipped and so are not reunited with their families. Since April 2023 we have rehomed over 40 unclaimed dogs through our charity partners.

Whilst it's a dog breeder's responsibility to ensure puppies are microchipped before selling them, you should check that the chip details for your dog are correct.

If your dog isn't already microchipped, your local vet can help. Prices vary, but vets typically charge around £15. Some animal charities may offer microchipping for free to people on low incomes.

Recent changes in the law mean that from 1 January 2024, American XL bully dogs can no longer be rehomed by us. If you own one of these dogs, it's more important than ever that they are microchipped so they can be returned to you if they go missing.

Your Local Plan, your say

We want to hear your views on our proposals to meet the District's future housing and development needs.

We have been working on 'Plan 2040', a new Local Plan, which sets out what can be built and where over the next 15 years.

Plan 2040 will help to deliver much needed new homes, including affordable homes, while promoting health and wellbeing and protecting the environment and the overwhelming majority of the Green Belt.

Last autumn, we asked for your views on 'Plan 2040' priorities. These are:

- Delivering new homes, including affordable homes and houses for older people
- Making the best use of land within existing built up areas
- Supporting our economy and high streets and delivering the right type of workspaces to meet current and future needs
- Protecting the environment and the majority of the Green Belt, along with natural resources and local character
- Improvements to transport and infrastructure
- Ensuring new developments promote good mental and physical health
- Tackling climate change by ensuring new developments have the minimum impact on the environment, including low carbon emissions

- Good design so new developments provide high quality places and spaces.

While the new Local Plan proposes to make the best use of land within existing built up areas, we face a big challenge as Government has told us the Sevenoaks District needs 10,860 new homes from 2025 to 2040.

As the District is 93% Green Belt, the third highest proportion in England, we have to consider a limited number of Green Belt sites to meet our housing and development needs.

The sites put forward in Plan 2040 are in the most suitable and sustainable locations close to existing settlements, transport and services. The majority of these sites have been assessed to be poorly performing Green Belt.

We're currently consulting on our latest proposals and we're keen to hear your views. You can have your say now and until midnight on Thursday 11 January 2024.

Sliding to victory!

Sevenoaks Skeleton star, Issy Fassnidge, has her sights set firmly on the 2026 Winter Olympic Games in Italy.

The 20-year old, who grew up in the town, has already represented Team GB and spoke with In Shape about all things Skeleton.

"I was competing for Tonbridge Athletics Club on the track when someone suggested I apply for 'Girls 4 Gold', a selection process run by British Skeleton for the 2026 Winter Olympic Games. I thought why not and decided to apply.

"At the time I had no idea what I was getting myself into. I knew of Skeleton double Olympic gold winner Lizzie Yarnold, who grew up in West Kingsdown, but not much else!"

"Two hundred and fifty people applied and, after the grueling physical and mental tests, I made it to the last seven. When we entered full time training at Bath University, I realised how exciting and fun the sport was, and as an adrenaline junky, I knew I wanted to pursue it further.

Issy, who is now based full time at Bath University, trains most days. Issy says: "Right now I'm doing a lot of gym work and sprinting. Most of the training is to build my leg strength as this helps when pushing at the start of the race. We also have a push track, which mimics the downhill run at the start of Skeleton.

"It was a very proud moment when I was selected to represent my country and last year was my first full season of racing. So far I've competed in three competitions and in Innsbruck, Austria I won a Bronze medal in the Under 20s Junior European Championships.

"What I love about Skeleton is travelling to new places, competing and taking in the most incredible views. My favourite track is Innsbruck and racing here is surreal. You get to stand at the top of the track surrounded by mountains. This, coupled with sliding at over 70mph and competing against other nations is such an amazing feeling."

"My goal now is to compete and win at the 2026 and 2030 Winter Olympics. In the meantime

I intend not just to defend my European Championship medal at Lillehammer in Norway, but to go one or two better and bring home a Silver or Gold!

Issy has received support from the Sevenoaks District Sports Council along the way. Issy says: "They've been incredible in helping me towards my Olympic goal. Their support has meant I don't need to work every night after training. They paid towards a new speed suit, assisted with free gym membership and have helped to raise the profile of Skeleton.

Businesses and communities cash in on grants

Rural businesses and community groups, based in the Sevenoaks District, have secured thousands of pounds to create new jobs while tackling climate change.

Recently we allocated £125,000 from the West Kent Rural Grants scheme, funded by the Government's Rural England Prosperity Fund, to support rural enterprises. Applicants applied for funding over the summer and nine were successful each receiving grants worth up to £25,000.

The funding is projected to create nine new jobs, while protecting six existing jobs, and will help six businesses and community groups to reduce their carbon footprint. A further 31 suppliers, who provide goods and services to the successful applicants, are expected to benefit from the funding.

Council Leader, Cllr Julia Thornton, says: "This important source of funding will help our thriving economy to further develop and grow enterprises while helping to reduce the District's carbon footprint. I am very proud we were among the first local authorities in the country to allocate the funding so it can make a difference as soon as possible."

Locally, the Government's Rural England Prosperity Fund is being administered by us for the West Kent Partnership of Sevenoaks District Council, Tonbridge and Malling Borough Council and Tunbridge Wells Borough Council.

Rural businesses and communities can apply now for funding

The next round of the West Kent Rural Grants scheme is now open for applications.

Grants up to £25,000 are available for rural-based businesses and community groups for capital projects. Terms and conditions apply and match funding is required.

Successful applicants will receive their funding in the 2024/25 financial year from next April, subject to release of Government funding.

How to have your say on planning applications

Public comments are an important part of every planning application we consider.

We have the busiest planning department in Kent, dealing with some 2,000 planning applications a year, and all public comments are carefully considered before we reach a decision on every application.

Here's how you can find out about local planning applications and have your say:

How we advertise planning applications

- We write to immediate neighbours and sometimes there will be notices close to the site of the planning application
- All applications are publicised on our planning website <https://pa.sevenoaks.gov.uk>. Here you can search for an application by reference or address. You can also register to be informed of planning applications in your area
- Some applications are publicised in a local newspaper

- We share a weekly list of planning applications with District Councillors, town and parish councils and groups and resident associations that have requested them. You can ask to receive our list by emailing planning.validation@sevenoaks.gov.uk.

How to have your say

- All planning comments have to be in writing
- The easiest way is to comment on our planning website <https://pa.sevenoaks.gov.uk>
- You can also comment by email or post. Please include the planning application reference and address along with your name and address
- Anonymous comments cannot be taken into account
- Your comments, but not your name, address and email address, will be made available on our planning website.

What we can and cannot consider

Government guidance says we can only consider comments about planning issues. These can include:

- Overlooking, loss of privacy or light and overshadowing
- Highway safety, traffic and parking
- Noise
- Layout and density of building
- Design, appearance and materials
- Impact on listed buildings and conservation areas
- Disabled persons' access
- Ecology and biodiversity
- Government and local planning policies

Issues such as the loss of a view or the impact on property values are not deemed to be planning issues and therefore cannot be considered.

"We are a small, loyal team that put our swimmers first," says Mark Horne, Swimming Coach and Swim Manager at Sevenoaks Leisure Centre. "This allows us to not only know all the children by first name, but also the parents, achieving a family-first approach. It's completely natural for parents to be nervous for their child to begin swimming lessons but, as not all children learn at the same rate, we adapt our lessons as needed for each child, suggesting one-to-one sessions if needed.

"Swimming is not only a great form of low impact sport for people with a wide range of conditions, it is one of the most important life skills we can teach children - not only as a very inclusive sport, but as a safety skill which will stay with them for life."

Recognising the benefits of the classes, Olivia, mother of three-year-old Kitty, adds: "Kitty's confidence has grown so much since her lessons began. At first, she struggled to get into the water without me, but by



week two she was jumping into the pool! Kitty's teacher is always encouraging the children, and no one is ever left out as all abilities are catered for."

For Kitty, learning to swim has helped her confidence and sense of

feeling safe around water. She says: "I can swim on my own now - I love jumping in!"

The Mill Pond is back to its best

Work to improve a historic pond for the benefit of wildlife and people was completed over the summer.

The Pond, on the junction of Seal Road and Mill Lane in Sevenoaks, is home to waterfowl, amphibians, insects and reptiles, and is much loved by local people.

But over the years it has become silted, impacting its appearance and ability to support a wide variety of wildlife.

Mill Pond is fed by nearby springs and storm water from highway drains. Silt from the roads and nearby building projects had, over time, built up.

Oil and other pollutants from the roads washed into the pond and in 2021, it suffered contamination from a Thames Water culvert.

In recent years, Greatness Residents' Association secured funding to transform the pond into a nature reserve. This included new silt traps, nature friendly plants and benches.

To support the Association's ambitions, we started work on a £60,000 package of improvements in March.



Specialist contractors were brought in to desilt the pond and additional wildlife-friendly greenery was planted.

The rotten wooden boardwalk was replaced with a new, accessible cinder concrete path and wooden railings allowing better access so we can maintain the pond going forward.

Cllr Margot McArthur, our Cabinet Member for Cleaner and Greener, says: "Thanks to the work of Greatness Residents' Association and the Council, Mill Pond has been completely transformed. The improvements include reducing the steep bank by the pond and putting in a new lower gradient path making the site accessible to people with prams and in wheelchairs. In the coming months and years, we expect the Mill Pond to flourish once again for both nature and residents."

Helen says: "The walks run on a regular basis, and you know if you come along, then there will always be someone else to walk with.

"We enjoy some lovely views, which always lift the spirits, and it's great to see the changing seasons and the array of wildlife.

"There is medical evidence that regular walking reduces the risk of heart disease, stroke, type 2 diabetes, colon and breast cancer and Alzheimer's disease by more than 20%."

Steps to Wellbeing walks are free and open to all adults who can walk three miles over varied terrain, which includes uneven paths and some hills. Dogs are always welcome as long as they are kept under control.

Helen adds: "Come along and try a walk for yourself. It's always fun meeting all the lovely people and hearing about their interesting lives. I always feel better for getting outside and find I sleep better too."

Lose weight, your way!

Successful weight loss looks different for everyone. It's about finding out what works for you as local resident, Steve Thompson, discovered earlier this year.

Steve, 68 from Sundridge, has several health complications, including COPD, Rheumatoid Arthritis and Pulmonary Fibrosis, which has meant he hasn't been able to do exercise for many years. These conditions were made worse as Steve was considerably overweight, so his GP referred him to our One You service.

Steve says: "I had my first face-to-face meeting with One You's Natalia in January 2023. Natalia gave me a full assessment which wasn't just about the weight I needed to lose but also how I wanted to change my lifestyle and what my ultimate goals were. Once Natalia understood my thought process, she explained the challenges I would face to achieve the end result I wanted."

In the past, Steve would lose weight by crash dieting, which would work to begin with, but then the weight would go straight back on again.

"Natalia explained why my approach wasn't working and that I needed to lose weight in a much more controlled manner. She encouraged me to set myself sensible targets over the coming weeks, including adding more healthy foodstuffs, like fruit and vegetables into my diet."

Because of Steve's health issues, exercise didn't come easy, but Natalia set achievable targets such as walking a little bit further and faster each day. Despite the challenges, Steve stayed on track.

Steve attended regular sessions with the One You team to give updates on what he'd achieved, his weight loss over the period and what new challenges he was setting himself.

"I am pleased to be able to say that I have succeeded in losing almost three stone in weight. I can now wear clothes I haven't worn for ages, I don't have to rely on my inhalers as much and it has massively improved my mental health. I can even take my dogs for long walks, something I haven't been able to do for some time.



Steve's new found health has meant he is even considering going skiing again with his children and grandchildren for the first time in many years.

"I cannot recommend Natalia and the One You service highly enough! Anyone who finds themselves in a similar situation as I was in should consider seriously getting the help that One You and people like Natalia can give. I'm a 68 year old, now feeling like a 58 year old!"

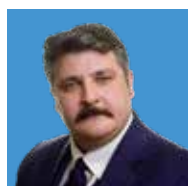

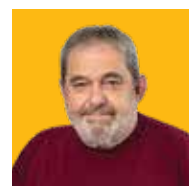

Protecting your property

We are always ready to get into the Christmas spirit and sometimes this leads to us and our property being a bit more vulnerable.



Criminals will often take a chance at this time to take what is not theirs. Here's how to make your home that bit safer over the festive period and the whole year round:

How to protect your home:

- Ensure doors and windows are secure before leaving your property
- Keep keys, cash and expensive items out of view
- Use timer switches on lights and radios to make your home look occupied
- Keep gates locked and boundaries secure
- Lock away bikes, tools and garden items that could be stolen or used to break into your home
- Be mindful of your discarded rubbish as it could advertise new and expensive items such as games consoles and new TVs

Reporting anti-social behaviour and the Community Safety Unit

The Community Safety Unit (CSU) consists of Council staff, Police, Community Wardens, Housing Associations and other partners. The CSU deals with all aspects of anti-social behaviour and community safety.

Partners meet daily to discuss community safety concerns and any crime or anti-social behaviour calls that have come in from residents or the Police.

The CSU allows us to have a speedy and effective response to residents. Please be assured that all information is treated in confidence and we will keep your details anonymous if you prefer.

If you witness anti-social behaviour, you can report it to us by emailing community.safety@sevenoaks.gov.uk or phoning **01732 227000**.

We also have an X (Twitter) account which you can follow at [@sdc_csp](https://twitter.com/sdc_csp). Please be aware we cannot act on a report from X so please tell us about your concerns by phoning Kent Police or reporting online.

You can also join Kent Police My Community Voice via www.mycommunityvoicekent.co.uk. This is a two-way engagement tool that allows you to inform Kent Police of local issues.

If life is in danger or a crime is in progress, always call **999**. For non – urgent police matters call **101** or report online via www.kent.police.uk.

Changes to postal and proxy voting

The Government has introduced some changes to the rules around postal and proxy voting, including the ability to apply for both online.

Postal voting

Previously, if you had an indefinite postal voting arrangement, it was permanent until you asked for it to end.

From now on, you will need to reapply for your postal vote every three years unless you have a postal vote for one election or for a set period of time less than three years.

If you currently have a postal vote, and you want this arrangement to continue, you will need to reapply before 31 January 2026. We will send you the information you need prior to the deadline.

When you apply for a postal vote you will need to provide your national insurance number.

Proxy voting

A proxy vote allows someone to vote on your behalf.

Currently, an individual can act as a proxy for an unlimited number of close relatives and two other people.

Under the new rules, a person can only be a proxy for up to two people living in the UK, or a maximum of four people, with two people living in the UK and two people registered as living overseas.

If you apply for a proxy vote, you will need to provide your national insurance number.
